To obtain a preliminary injunction, a party must establish ( 1 ) a reasonable likeli-hood of success on the merits; ( 2 ) irreparable harm; ( 3 ) the balance of hardships tip-ping in its favor; and ( 4 ) the impact of the injunction on the public interest.
